Please see the attached itemized breakdowns of the data set products at IMDb as well as a deck with a bit more information/examples.

We can 100% cover all of the data verticals you are requesting with one exception, we do not license Headshots due to legality reasonings. The package titled Movies/OTT/TV Essentials has you covered on the bulk of the verticals you are looking for but does not have Box Office info, The Box Office package includes everything the Essentials package does and also has Box Office Mojo Data.

We would like to explore the possibility of consuming some of your metadata, via your API or any other approach that you could suggest.

Please could you provide licensing information?

Please find some details of our proposed usage below.

Data to Be Retrieved

Descriptive metadata for movies. series and episodes including

1. Titles in English, Italian & Spanish where available
2. Release Year / First Air Date
3. Cast lists, names etc.

4. Episode numbers, titles.
5. Images: posters, headshots

Additional optional items

- Parental rating
- Score / Viewer Rating
- Additional IDs
- Box Office information

Example Use Case

1. User queries within our system for “movie” name like “Jaws”.
2. System displays list of matching records from your system
3. User chooses a record
4. System imports the data.

Volumes

Load varies, since it is driven by receipt of new contracts and whether those titles already exist in our systems however we receive approximately

- 3,000 new movies per year
- 100 series (with seasons & episodes)

Users may of course make queries without retrieving full sets of metadata.
